 1 day of October the year of our lord in ccccxxvij and the xvj yere of the reigne of king Henry  
 the viij th[is] yewl that my fforst fforster margarete my wif my execvutor in my testament namyd  
 and ordeynyd to occupye and take the p[ro]fessys of all my maner londes and tenementes that I have  
 within the tyme of fforst except the londes that I have by deuise late my wif and except the man  
 and manion of crall and the londes called the dene whiche call stolz lond fforson skybys  
 whiche long fforst manysombyt hys the tenement wyle imberlond ducell stode morganlond  
 pollerdystret baron mclandis mellehorham lyllyham blensfeldys binges wylle the  
 park and the gardynes adioynynge to the said manyon and except also all my lond in bingasse  
 and the londys in warldys called clare and except also the maner of Crotcham and all the  
 londes and tenementes that I have in the yersys of wesel for the tyme of my decease unto  
 thende and termes of my pore thame next ensyngynge to thement that myne execvutor with  
 hisselfe and p[ro]fessys thereof shall xponne the my last yewl at after shal enfylle also  
 yewl that margarete my wif shall have the maner and manion called crall and all the said  
 londys and tenementes called the dene whiche call stolz lond fforson skybys whiche  
 long fforst manysombyt hys the tenement wyle imberlond ducell stode morganlond  
 pollerdystret baron mclandis mellehorham lyllyham blensfeldys binges wylle the  
 park and the gardynes adioynynge to the said manyon for tyme of her lyf if she wyl  
 a byde and dwelle therapone and if she wyl nat dwelle therapone thame gwyll that my  
 fforst shall mak to her assygnement grant of a perch rote of 2 m[ile] by perche for tyme  
 of here lyf out of the said manyon and londes with a suffygent clense of defaute for  
 lacke of payment of the same and thame myne execvutor to waite the residu of mynd  
 and p[ro]fessys of the said londys and tenementes called the dene whiche call stolz  
 lond fforson skybys wyle longfylde manysombyt hys the tenement wyle imberlond  
 ducell stode morganlond pollerdystret Baron mclandis mellehorham lyllyham  
 blensfeldys binges wylle the park and the gardynes adioynynge to the said manyon  
 tell that my sonne willm come to thysys of myn yere and thame my fforst to make  
 therof atte to him and to therof of his body lawfully be gotten and for lacke of such  
 fforst the remenyndre therof to thom[as] my sonne and to thom[as] malib of his body lawfully  
 be gotten and for lacke of such fforst the remenyndre to robert my sonne and to hit heire  
 malib of his body and for defaute of such fforst the remenyndre to my right heires and  
 alij yewl that when thome my sonne comyngh to thysys of myn yere thame my fforst

I shall make aware to him of all my lordis that I have purchased in any place from the shire of sussex except  
my lordis in the shire of burgess to have to him and to thairt malis of his body commong and fer  
descantz of such heires the remayndz thereof to wyllm and to thairt of his body and fer descantz off  
such heires the remayndz to Robert my sonne and to thairt of his body also swyl that my daughter  
joham shall have all my saide lordis in the shire of burgess and my lordis in wales called  
clarence for herme of here lyff and after here decesse swyl that wyllm my sonne shall have the said  
lordis called clarence to him and to thairt of his body lawfully be gotten with the remayndz at  
ys before wyld of the maner of Cravell also swyl that usys the decess of margarete my wif that

lacke of such heires the remayndz thereof ou as ys before rehersal of the purchased lordis  
swyl that myne executry shall kepe hysselfe and proffter of all myn said lordis be fer  
swyl to my said sonnes all therid agyd by fore hysselfe that onys of them shall have a  
franchise of his parte and with the proffterys thereof shall fende my said sonnes thome Robert & pole  
and otherwys as shalbe convenient for them by the discrecion of myne executry and the  
money of onys of the partes that shalbe a bone ther frifte the resonable reparacions  
costs and expences refind and alredy shalbe payde and delivred by myne executry  
to him that shall have afeare of the lordis that the pessisit so taken of at his said age  
so that he be ruled and gydyd by myne executry and troubl nat this my last wyll and if  
that they or any of them wyllnat be rebled and gydyd by myne executry or troubl or  
lett this my last wyll thanne swyl that the proffterys so taken of hit or of them lordis that  
wyllnot be rebled by myne executry shalbe disposed by myne executry for my swyl my  
ministes swyl and all other swyl in dedyt of charite & these witnessse thome & richard hechesys  
Henry dyce thome & ryan John Poope and Richard hechesys
