A native of Statesboro, Georgia, the late Alvaretta Kenan Register received her baccalaureate degree from Georgia State College for Women in Milledgeville, Georgia, and her master's degree in social work from the School of Social Work, Tulane University, New Orleans, Louisiana. She was immediately employed by the Georgia State Welfare Department where she was called upon to organize USO Travelers Aid at Fort Benning, Georgia. She was subsequently transferred to Norfolk, Virginia, to organize USO Traveler Aid for the naval personnel and their families there. Quickly rising through the ranks to become an executive, she joined the staff of the Norfolk Social Service Bureau and again was commissioned to reorganize that agency. She served as the superintendent of the Social Service Bureau of the department of Public Welfare in Norfolk for 24 years and retired from her professional career on March 1, 1973. Under her leadership her staff increased from 45 to 533 positions and her budget grew from approximately \$800,000 to over \$27.6 million a year.

In anticipation of her retirement she enrolled in the American Institute of Genealogy Research and upon graduation pursued courses of study in genealogical research from the North Carolina Archives, receiving her board certification as a Certified Genealogist. Recognized for her scholarship, har untiring energy and attention to detail, she became intensely involved in her chosen avocation - genealogy.

Her published works include The Kenan Family (1967); One Branch of the Parrish Family of Bulloch County, Ga.; Bulloch County, Ga., Marriage Records 1796 through 1875; all census records of Bulloch County, Ga., from 1820 through 1880 and Bulloch County, Georgia, Genealogical Source Material (1985). She was a frequent contributing editor of the Georgia Genealogical Magazine.

Mrs. Register was listed in the First Edition of Mho's Mho of American Women; Fifth Edition of Who's Who in the South and Southwest; 1964 Virginia Lives: Old Dominion Who's Who. She served as District Governor of Quota International (classified club of women executives as Kiwanis); State President of the Virginia League of Local Public Welfare Executives and in 1963 was awarded the Civitan Club's annual award for outstanding public service. She also received the Meritorious Service Award from the City of Norfolk's Department of Public Welfare for 30 years service in the field of social service.

She was a life member of the National Society Daughters of the American Revolution, State President of the Georgia Society Colonial Dames of the XVII Century, Daughters of American Colonists, Magna Charta Dames, Americans of Royal Descent and others.

Mrs. Register died on April 22, 1985. Her "family" had enlarged to encompass the numerous friends and loved ones that she came to know so well through the channels of the work that she loved.

Tyrrell County, North Carolina, was created 1729 out of Chowan, Bertie, Currituck and Pasquotank Counties, with Columbia as the county seat. 11 Nathaniel Everett's land fell into the new Tyrrell County.

Nathaniel Everett was Executor of the Will of William Jordan, Tyrrell Co., July 4, 1732; probated November 2, 1732,12

- 15 Aug. 1737 Thomas Lee in Tyrrell Precinct of Albemarle Co. sold to Nathaniel Everet for 31 lbs., 100 acres in Tyrrell Precinct, part of a tract adjoining a tract known as Mary Bowlers. . . . 13
- 15 ---- (torn) 1737, Nathaniel Everett, Sr., bought from Thomas Lee, a parcel of land, patent to William Downing bearing date of 30 March 1721 . . . Hewes Swamp. 14

The following is an abstract of a Memorandum written by Nathaniel Everett of Chowan County, N.C., 2 September 1720.

Nathaniel Everitt of Morattock in Chowan, planter to Mary Everitt, 2 Sept. 1720 for the love and affection I bear my wife now dwelling with me at my Plantation in Morattock, acres (not given), being my Maner Plantation which I now dwell upon except the lands I hereafter dispose of and at the death of the sd. Mary the sd. land and Plantation to go to my son Nathaniel Everitt. I also give 100 acres, joining 2 swamps between Zachariah Girkin and Benjamin Blount to my eldest daughter Mary Everitt. I also give to my daughters Elizabeth Everitt and Sarah Everitt that land called Possimon Neck. To my wife Mary, all my personal estate for her life and at her death it is to be divided between my children above mentioned. Wit.: Benjamin Blount, Richard Swinson, John Edwards. Ack. by Rd. Swinson 4 Sept. 1720 before me Fred Jones, Ch. Just. 15

Another document was made by Mathaniel Everett in Tyrrell County, N.C., 20 October 1744, and registered 23 November 1744.

Memorandum that on the twenty ninth day of October Anno Domini 1744. Nathaniel Everitt of Tyrrell County, planter, dwelling at Conniber Creek Swamp commonly called Morratock Swamp, who heretofore signed a deed of instrument of writing purporting a last will and testament or to that effect, dated September the second Anno Domino 1720 whereto were witnesses Benjamin Blount, Richard Swinson and John Edwards. Entered on the land and plantation in the said instrument of writing mentioned by the name of his the said Nathaniel Everitt, manner plantation and where the said Nathaniel now dwelleth at this presents and being in quiet and peaceable possession of the same, he did deliver the like quiet and peaceable possession of the same, by turff and twig unto Nathaniel Everet in the said instrument of writing mentioned which said Mathaniel last mentioned was born at Kendrick's Creek plantation then belonging to Edward Mosley Esq. but now in the tenure and occupation of Thomas Cooper, the said Nathaniel the elder being then tenant about thirty seven years past to the said Edward Hosley. To have and to hold the said manner Plantation in the said instrument of writing mentioned unto him the said Nathaniel Everet the younger, his heirs and assigns according as the same to mentioned in the said writing, the afore mentioned possession taken and delivered by turff and twig unto the said Nathaniel the younger in presence of us.

The Will of Nathaniel Everett was made in Tyrrell County, N.C., 2 November 1749 and probated at the Court House in Kendricks Creek 5 December 1749. His mark (AC) is identical on the deed of 30 October 1744 and the Will of 2 November 1749. It is quoted in full. The author has a xerox copy obtained in Tyrrell County, N.C.

In the name of God A Men. 1, Nathaniel Everitt of the Parish of St. Andrews and Province of North Carolina, planter, being of sound mind memory, knowing the frealty of human nature, after recommending my soul to Almighty God in full hope of a last and true resurrection to everlasting life, I make and constitute this my last will and testament. Disposing of all my worldly goods in manner and form following.

Item. I give to Nathaniel Everitt of New River one shilling starling.

Item. I give to Elizabeth or Mary Everitt of Mereland one shilling starling.

Item. I give to Elizabeth Ray one shilling starling.

Item. I give to Nathaniel Everitt of Mereland one shilling starling.

Item. I give to Sary Faggin one shilling starling.

Item. I give my lands and plantation to Nathaniel Everitt of the Parish of St. Andrews in the County of Tyrrell and Province of North Carolina which sd. Nathaniel Everitt was born att. Kindreck Creek in the year seven hundred and seven on a plantation then belonging to Edward Mosley Esq. to be enjoyed and prossed (possessed) by him and his heirs or assigns forever with all my other estate real and personal do appoint him the sd. Nathaniel Everitt the hool (whole) and sole Executor of this my Last Will and Testament. In witness hear of I have hearunto set my hand and Seal this 2nd day of November in the year of our Lord one thousand seven hundred and fortynine. Signed sealed and delivered in the presents of

Composition of the Family of Nathaniel Everet

Nathaniel Everet's wife was Mary but her maiden name is not known to the author. She was living at the time of the deed 2 September 1720 but was dead at the time of the deed 29 October 1744. Children of Nathaniel and Mary Everet:

Mary Everett, born ca 1701 Elizabeth Everett, born ca 1702 Sarah Everett, born ca. 1703 Mathaniel Everett, Jr., b. 1707

These birth dates were arrived at in the following manner: If Kathl Everet, Sr., was born as 1678, 16 he would probably have married at 21 years of age, which would be 1699. He gave land to two sons-in-law 25 March 171819 which means that those two daughters had married prior to 25 March 1718. If they were 15 years of age at the time of marriage, this would place the birth of the youngest on 1703. Nathaniel Everet refers to Mary as his eldest daughter. 20 Nathaniel Everet gave the date and place of birth of his son, Nathaniel Everet, in his Will.

Mary Everet, born ca 1701, Chowan Co., N.C.; died 1738; 21 married Thomas Stubbs who died 1737, 22

Mathaniel Everitt sold to Thomas Stubbs of Chowan Precinct 100 acres joining Benjamin Blount and Zachariah Girkin for 25 lbs. on 16 Feb. 1722; land near Horattock Bridge, 23

Nathaniel Everet was witness to the Will of Thomas Stubbs, Beaufort Co., Jan. 17, 1738, probated Aug. 7, 1737/38, then was executor. Thomas Stubbs named his wife Mary, a son Everitt Stubbs; other sons William, John, Richard; daughters Hannah and Mary. (Dates in Grimes are inconsistent with Minutes of the Court of Pleas and Quarter Sessions, 2²⁶ Also a daughter Sarah.

On the first Tuesday in March 1737, the will of Thomas Stubbs was proved in open court by the oath of Sarah Fagans, one of the subscribing evidences. $^{\rm 25}$

The first Tuesday September 1738, the Court ordered on motion of William Stubbs and Thomas Stubbs, two minors, that they might have Nathaniel Everard (Everet) Sr. for their guardian. Nathaniel Everet Sr. having moved that he might have the administration of the estate of his daughter deceased. Granted. 26

The first Tuesday of June 1739, William Stubbs, minor, petitioned the Court that Nathaniel Everet Sr. give security for his guardianship in the sum of 1,000 lbs. An account of the sales of the sates of Thomas and Mary Stubbs, deceased, was proved and returned, and ordered filed. An inventory of the estate of Thomas and Mary Stubbs was proved and filed by Nathaniel Everet Sr.²⁷

5 Sept. 1739, the Court ordered that the estate of the late Thomas Stubbs deceased, be divided amongst the children of said Stubbs, and that William Roads, Daniel Garret, Benjamin Blount, be appointed to make a division. 28 Elizabeth Everett was born ca 1702, Chowan Co., N.C.²⁹ She married prior to March 25, 1718 to Benjamin Blount, son of Thomas Blount.

Nathaniel Everitt of Morattock in Chowan Prect., planter to Benjamin Blount of the same place, my son-in-law, Planter, 25 Mar. 1718. 5 lbs. current money of N.C., 100 acres called Johnson's Reck, joining Morattock swamp and Haw branch. Wit: Mathew Casewell, John Worley. 30

The Last Will and Testament of Benjamin Blount was dated 1 Feb. 1739 and proved in Court the first Tuesday of June 1740 in Tyrrell Co., N.C. He named his wife Elizabeth; sons: James, Jacob. Edmund. Isaac, and Benjamin who was given the Manor Plantation of his father; daughters Esther, Mary and Sarah. Executors: son Benjamin and wife Elizabeth. Wit: Ann Hollis and Zachariah Gurkin. Ji

Sarah Everett was born ca 1703, Chowan Co., N.C. She married prior to 25 Mch. 1718 to Zachariah Gerkin (also spelled Gurkin, Girkin).

Nathaniel Everitt of Morattock in Chowan Prect. to Zack. Gerkin of the same place, my son-in-law, Planter, 25 Mch. 1718, 5 lbs. for 60 acres, part of Possimon Neck Lying in the fork of Haw branch. Wit.: Mart. Casewell (his mark). 32

Names of children of Zachariah Gerkin and wife, Sarah Everett, have not been located.

Nathaniel Everett, Jr., was born 1707 at Kendricks Creek in Chowan Co., N.C. After the death of Nathaniel Everett, Sr., Nathaniel Everett, Jr., is shown as Nathaniel Everett, Sr. 33 The the sake of clarity, he will be referred to as Nathaniel Everett, II.

He was a planter and this shows in real estate transactions. The land and plantation of his father was given to him "by turff and twig" between 1720 and 1744 as reflected by the two instruments of those dates.

The date of his marriage is not known, but he would have been 20 years of age in 1727, so probably married soon after that. His will named his wife as Elizabeth but her maiden name is not known to the compiler.

Mathaniel Everett, II, was appointed along with others, to a jury to lay out the road between Elizabeth Bell's and the Main Road leading to Morratuck Bridge, December 1739.34

Nathaniel Everet, II, proved in court, the sale of land from Francis Ward to Nathaniel Everet, Jr. (111), Sept. 1751, 35

Nathaniel Everett was appointed to help lay out a road, 5 March 1762.36

Nathaniel Everett was on the Jury of Tyrrell County, 23 March 1764,37

Nathaniel Everitt, II, made his will in Tyrrell County, N.C., 20 Feb. 1782; it was probated lat Monday July 1782. 38

In the name of God Amen. 20 day of February in the year of our lord 1782. I, Nathaniel Everitt of North Carolina and Tyrrell County, being very sick and weak in body, but of perfect mind and memory thanks be given to God for the same and calling to mind the mortality of my body and knowing that it is appointed for all men once to die, do make and ordain this my last Will and Testament: that is to say principally and first of all I give and recommend my soul into the hands of God that gave all and for my body I recommend to the Earth to be buried in a Christian like and decent manner at the discretion of my Executors, nothing doubting but of the general Resurrection I shall receive the same again by the mighty power of God, and as touching such worldly Estate wherewith it hath pleased God to bless me with in this life I give and dispose of the same in manner and form following, that is to say:

Item. I lend unto my well beloved wife Elizabeth Everitt during her life the plantation and land whereon I now dwell, my riding horse bridle and saddle and a third part of all the movable Extate. And after her decease the said plantation and all the land thereunto belonging to return to my son Joseph Everitt to him his heirs and assigns forever.

Item. I give and bequeath to my two grand children the two sons of my son Nathan Everitt, dec'd. John Everitt and James Everitt, the plantation and all the land thereunto belonging where he the said Nathan Everitt lived, to be equally divided between them when the youngest comes of age only reserving unto Elizabeth Everitt their mother her widowhood in the said plantation and land to them their helrs and assigns forever.

Item. I give unto the heirs of my son Joshua Everitt dec'd., one shilling sterling.

Item. I give unto the heirs of my daughter Lydia Griffin dec'd. one shilling sterling.

Item. I give unto the heirs of my son Edmund Everitt dec'd. one shilling sterling.

Item. I give unto the heirs of my daughter Mary Airs dec'd, one shilling sterling.

Item. My Will and desire is that the whole of my Estate not already given not disposed of together with my wifes thirds of movables at her decease to be equally divided between my children hereafter named - all except her thirds at my decease as followeth: Thomas Everitt, Nathaniel Everitt Jr., Hannah Harrison, Zilpah Griffin, Bilhale Jones, Sarah Gardner, Elizabeth Heazel, Jehu Everitt, Jeremiah Everitt, Joseph Everitt, and John Everitt to them their heirs and assigns forever.

I do hereby constitute appoint and ordain my son Thomas Everitt and Joseph Everitt my whole and sole Executors to this my Last Will and Testament, and I do hereby utterly disallow revoke and disannul all and every other former Testaments Wills Legacies bequests and Executors by me in any wise before named willed and bequeathed ratifying and confirming this and no other to be my last Will and Testament. In witness whereof the Testator have interchangably set my hand and seal the day and date above written. Signed Sealed and declared in the presence of us.

Nathaniel Everitt (his seal)

First Monday July 1782. Appeared Renjamin Harrison and proved the Last Will and Testament of Nathaniel Evrett. Thomas Evrett, Esq. and Joseph Evrett qualified as Executors of the estate of Nathaniel Evrett, deceased.

Joseph Evret returned the inventory of the estate of Nathaniel Evret, deceased. $^{\mbox{\scriptsize J9}}$

Thomas Evertt appeared in open Court and prayed division of estate of Nathaniel Everet. Granted. 40

An appeal from Elizabeth Everet and John Airs was filed. 41

First Monday January 1783. Benjamin Blount and Jeremiah Frasure exhibited in open court, the division of the estate of Nathaniel Everet, deceased. 42

4 Jan. 1787. On motion, the Court ordered that the Executors of Mathaniel Everett, deceased, shall be summoned to the next Court to appear and declare what property they may have in their hands belonging to Jehu Everitt. 43

5 April 1787. Thomas Everett and Joseph Everett, Executors of Nathaniel Everett said they have no property of Jehu Everett, and upon examination said Jehu Everett conveyed away his property with intention to defraud Sarah Hollis by whom he has a bastard child (illegible) any support she might be entitled to. Ordered by Court that of Nathaniel Everett, deceased, at the death of widow of said deceased, retain in their hands, the sum of thirty pounds of said deceased estate, and the said Jehu Everett will be antitled to so much for the support of said child.⁴⁴

The focus of this book is on the descendants of Nathaniel's son, JOHN EVERETT/EVERITT.

Descendants are eligible for Daughters of American Coloniats on the line of Nathaniel Everett. Service: "North Carolina, Tyrrell Co. A List of a Foot Company of Soldiers Commanded by Capt. Evan Jones. By Commission Bearing Date the 17th Jany. 1747. For the District between the Bark Poplar Swamp and Welches Creek." This list contains 92 names, including that of Nathaniel Everit. (Located in N. C. State Archives.)

John Everett and his wife, Sarah Fagan

John Everett, the subject of this book, was born in Tyrrell County, North Carolina, 1743, 45 son of Nathaniel Everett and his wife, Elizabeth.

John Everett was a private in the N.C. Nilitia for five years during the American Revolution, according to the pension application of his vidow, made 3 October 1842. In the course of the war, he was wounded in the shoulder by a rifle ball which remained in his shoulder until his death. This occurred at Batty's Bridge on Downing Creek near Peedee, which she thought to be in N.C. He served under Capt. DeJarnett from N.C. 46

John Everett married Miss Sarah Fagan cs 1772, probably in Tyrrell County, N.C. She was born 1746, daughter of Bedford Fagan and his wife, Hary. **7

The application for a pension made by Mrs. Sarah Everett, widow of

John Everett, states that the family moved to Georgia from N. C. in 1785. Beeds in Tyrrell Co., N.C., show that he sold his property to Joseph Jones on 4 January 1785. This was proved in Court by his brother-in-law, Richard Hoff. 48 At that time land which he obtained in Georgia was in Effingham County. His land was cut into Bulloch County when it was created in 1796, and they lived there until their deaths. 49

The first Justices of the Peace named by the Legislative Assembly to represent Bulloch County were: John Douglas, John Everett, Robert Scott, William McCall and Mark Pridgeon. SO Some of the earliest members of the House of Representatives in the State Legislature from Bulloch County were . . . John Everett, and his brother, Jehu. 51

John Everett was a County Commissioner and held that office November 7, 1801 when George Sibbald of Augusta, Georgia, deeded 200 acres to create Statesboro, 52

John Everett was Justice of Inferior Court of Bulloch County for several years. The first book of Minutes of the Inferior Court is missing, but in Book X (1815-1843), he is shown as a Justice from January 1815 through May 1819.53 He died in 1820.54

John Everett was a large land owner. The book, <u>Index to Neadright</u> and <u>Bounty Grants of Georgia 1754-1909</u>, shows that he received the following land grants:

Other listings for a John Everett are for either his brother, Jehu, or another John Everett from Tyrrell County, N.C., who came to Georgia ca 1800 according to an application for a pension from this second John Everett. He is distinguished from this one by referring to him as the John Everett who died 1840. John Everett, the subject of this book, was in Bulloch County by 1799 when two of these grants were made in Effingham Co. 55

John Everett died November 17, 1820. His widow gave the date of November 17 in her application for a pension. The Minutes of Inferior Court of Bulloch County, Book X, pp. 30, shows that the will was probated December 4, 1820.57

Will of John Everett:

In the name of God Amen. I, John Everitt of the State of Georgia, County of Bulloch, being in perfect mind and memory, do make and ordain this my last will and testament as follows: (to Wit)

lst. I give and bequeath (after my just debts are paid), all

my property both real and personal that remains at my decease unto my beloved wife Sarah Everitt to hold and enjoy during her natural life or widowhood.

2nd. I will and desire that at the marriage or death of the said Sarah Everitt that the whole of the above mentioned property be divided into seven equal shares or parts with the exception of such property as I have already disposed of or may hereafter dispose of either by deed or otherwise which said parts or shares shall belong to the following heirs, viz: Joshua Everitt, Josiah Everitt, Enoch Everitt, Jehu Everitt, Aaron Everitt, John Everitt and my daughter Hannah's two children, John and Sarah, to have one of said shares.

Lastly, I constitute and appoint my sons Joshua, Jehu and Aaron Everitt my Executors to this my last will and testament utterly disallowing any other former will by me made, ratifying this as my last will and testament. In witness whereof I have hereunto set my hand and seal this twenty nineth day of July in the year of our Lord one thousand eight hundred and twenty. Signed and sealed in the presence of

Since all property was left to his widow for her natural life, the estate was not divided until after her death May $24,\ 1851,^{59}$

Mrs. Sarah (Fagan) Everett outlived her husband and all seven of her children, being 105 years of age at her death. She lived alone 60

Mrs. Sarah Everett made a noncupative will as follows: Bulloch County, Georgia, Book 5-A, pp. 251-252.

We, Hannah Waters, Thomas Waters Sr. and Sarah Ann Brannen were present on Tuesday, the 20th day of May 1851, at the residence of Sarah Everett, a widow woman before and at the time of her death, about four days before her death in perfect possession of her mental faculties she called Sarah Ann Brannen as much as twice and Sarah Ann went to her with myself and the old man, meaning Thomas Waters Sr. She said I want Ann, meaning Ann Brown, the daughter of John Barber of said county, to have all the money in the house, then she said Mr. Waters you have got the notes and keep them until you collect the money and make up \$200.00 to Ann and then give Sarah Ann Brannen the balance. This 31st day of May 1851.

(Signed) Hannah Waters, Thomas Waters and Sarah Ann Brannen

This noncupative will was probated July 8, 1851 and Thomas Waters was appointed administrator. $^{6\,\mathrm{I}}$

The above will was promptly challenged in Court, and Court appointed her grandson, Jehu Everett, son of Joshua, as administrator of the estate of John and Sarah Everett. Receipts are found in Book 8A, pp. 18-22. Office of Probate Judge, beginning December 29, 1852. The following is a summary of the settlement of the estates.

Descendants of John Everett are eligible to join DAR or SAR on his line. The following is her SERVICE RECORD:

John Everett served as Private in the Militia of Morth Carolina. He was wounded in the shoulder by a rifle ball which remained in his shoulder until his death. This occurred at Betty's Bridge on Downing Creek near Peedee (river) in N.C. He served under Capt. DeJarnett from N.C. and in company with James Pickett; also with Col. Made when he retreated. (Reference: Pension application #3404 by his widow; affidavit in application describing his service.)

Caution: Do not use the sketch from Pioneers of Wiregrass Georgia by Folks Huxford, Vol. IV, pp. 84-85, because two men by the name of John Everett have been combined as though one mon-our John Everett or Everitt from Tyrrell County, N.C., and the other from Martin County, N.C., son of William Everett. This error has been accepted by the National Society Daughters of the American Revolution, and by Huxford Genealogical Society Quarterly.

JOSHUA EVERETT

11. Joshua Everett or Everitt, the eldest child of John Everett and his wife Sarah Fagan, was born 27 Sept. 1774, Tyrrell Co., N.C. 2 He moved with his parents to Effingham Co., Ga., in 1785. 3 His descendants who remained in Bulloch Co. use the spelling EVERETT, but with a few exceptions, those who moved to the western part of the state as new land was developed, use the spelling EVERITT.

Joshua Everett married 1 Oct. 1797 in Bulloch Co. to Jane Carter. She was born in N.C. 12 Oct. 1780 but satisfactory proof has not been found of her parents.

Joshua Everett owned a great deal of land. The Index to Headright and Bounty Grants shows the following land grants: 6

The first grant in the name of Joshua Everett has been omitted because it is dated 1797 in Effingham Co. and this Joshua Everett was in Bulloch Co. at that time. It was probably for a son of Jehu Everett, brother to our John.?

In addition to grants, Joshua Everett purchased land at Sheriff's sales. Example: Sheriff's deed from Robert McCall, Sheriff, to Joshua Everett, 149 acres for \$11.56 1/2, land of Enoch Pagen. 5

Joshua Everett was commissioned an Ensign in Bulloch Co., 25 Nov. 1806.9 He was commissioned Captain of the Militia for the 45th District of Bulloch Co. 18 Feb. 1809.10 The 45th District was known as the Clubhouse District, and is that part of Bulloch Co. which became Candler Co. when it was formed in 1914.

Joshua Everett was Justice of the Inferior Court of Bulloch Co. Although Justices were not listed in all sessions of Court, he is shown in the Minutes as follows: 1 Feb. 1819; 1 Mov. 1819; 3 Jan. 1820; 6 Feb. 1820; 3 July 1820; 4 Dec. 1820; 2 July 1821; and 3 Mov. 1821.

Joshua Everett's name is on the list of members of Lower Lotts Creek Primitive Baptist Church, Bulloch Co., March 1833, but the disposition shows he was "Excluded." 12

An analysis of pre-1850 census records of Joshua Everett and family was made, comparing it with Bible records. 13 All census records are of Bulloch County, Ceorgia. 1790, 1800 and 1810 census records burned.

Joshua Everett died in Bulloch Co., Ga., 14 Feb. 1846 and is buried in the Everett Cametery, then Bulloch Co., now Candler Co. 17

After the death of Joshua Everett his widow, Jane (Carter) Everett, continued to live in the home. In the 1850 census she is living with her youngest daughter Permelia and her husband Hampton Williams and their daughter one month of age. ¹⁸ In the 1860 census she is living alone, 79 years of age, but next door to her son Jehu. ¹⁹ Nampton Williams and wife Permelia Everett had moved to Thomas Co., Ga., where several of her brothers had preceded them.

Jane (Carter) Everett's children apparently became concerned about their mother living alone as she moved to Thomas Co. after the 1860 census. Descendants of her son Josiah J. state that she lived with him; and descendants of her oldest daughter Sarah Young, state that she died at the Young home Feb. 8, 1864. She is buried in the Everitt Cemetery, Boston, Thomas Co., Ca. 20

Sarah Carter Everitt was the eldest child of Joshua Everett and wife Jame (Carter) Everitt, called "Jincy."22 Sarah was born 7 Apr. 1799, Bulloch Co., Ga. ²³ and died 14 Apr. 1876, in Thomas Co., Ga. She married 25 Mch. 1819, Bulloch Co., Ga., to Michael Young. ²⁴ He was born 16 Jan. 1797, Screven Co., Ga., son of William Young and his wife Mary Henderson Ed died 24 Aug. 1856, Thomas Co., Ga. ²⁶ The family moved from Bulloch Co. to Thomas Co. about 1826 as new land was opening up in that area. Michael Young was an influential man in Thomas Co. He served as State Senator in 1830. ²⁷ Their children were:

John Carter Everett was born 1 Sept. 1801, Bulloch Co., Ga.; died 30 Nov. 1835, Bulloch Co., Ga.²⁸ married 22 Feb. 1824, Bulloch Co. to Elizabeth "Eliza" Ellis, ²⁹ born 26 May 1803, N.C., daughter of Benjamin Ellis and wife Absalean (thought by some descendants to be Mincey). She died 24 July 1851, ³⁰

Although John C. Everett did not live long (34 years) he took his place as a responsible citizen of the community at an early age as shown by the Minutes of the Inferior Court of Bulloch Co., Ga.: (1) July 5, 1824, the Court ordered that Henderson Fryer, John Anderson, John Miller, John C. Everett and Michael Young be appointed to appraise the estate of Jacob Putch, deceased. (2) Sept. 4, 1825, "Appeared in open Court, Jacob Mincey and John C. Everett, (who) produced the last will and testament of Philip Mincey, deceased, which was legally proven before the Court and said Jacob Mincey, and John C. Everett were qualified as Executors to the same." (3) May 3, 1830, John C. Everett and Jacob Mincey, executors of the estate of Philip Mincey, deceased, made application to the Court for letters of dismission from their executorship. (4) Sept. 2, 1833, Ordered that John C. Everett, Samuel Slater and William Goodman be discharged from the Securityship of the estate of John E. McCall. 31

John Carter Everett died 30 Nov. 1835, Bulloch Co., Gs. On 7 March 1836 the Court ordered that Josiah J. Everitt and Benjamin Ellis be appointed administrators on the estate of John C. Everett, deceased, ³² An Inventory and appraisement of the estate of John C. Everett, deceased, was made 30 Apr. 1836 by Benjamin Turner, W. B. Williams, and Jacob Nevill. ³³ 12 Jan. 1846, the Court ordered that Carrett Williams, Edmond Brannen, Benjamin

Turner, Bazzel Jones and William B. Williams be appointed dividers of the estate of John C. Everett, which estate is now in the hands of Benjamin Ellis.³⁴ Elizabeth Everett (widow) was appointed guardian of Margaret and John C. Everett, Jr., minors.

Heirs in the estate of John C. Everett were: Elizabeth Everett, widow; Henry Tillman (who married daughter Susan); James Tillman (who married daughter Sarah; Elizabeth Everett for her wards Margaret and John C. Everett, Jr. 35

John C. Everett is shown in the 1830 census of Bulloch Co. with three children under five years of age (2f and 1 m); and three slaves. His widow Elizabeth is shown in the 1840 census of Bulloch Co. with four daughters, one son and six slaves. Also in the home is her mother, Absalem Ellis, and she is living next door to her father-in-law, Joshua Everett, and near her father Benjamin Ellis. The 1850 census of Bulloch Co. shows her mother and her youngest child, John C. Everett, Jr., as the only ones left with her, 16

Elizabeth Everett died 14 July 1851. The Court appointed Jonathan B. Brewton as administrator of her estate. Appraisement of the setate was made 25 Sept. 1851 by Bazell Jones, Benjamin Turner, and Silas E. Bowen. 37

Distribution of the estate of Elizabeth Everett was made 7 June 1854 as follows: 38 (1) Benjamin Ellis, guardian of John C. Ellis, minor and heir of the estate; (2) James Tillman (m. daughter Sarah); (3) Henry Tillman, guardian of Elizabeth Tillman (daughter of Henry Tillman and his first wife Susan Everett, deceased, daughter of John C. and Elizabeth Everett).

114. Josiah Jefferson Everitt (Joshua², John¹) was born 10 Nov. 1806, Bulloch Co., Ca.; ⁴⁰ died 26 Feb. 1873, Thomas Co., Ca.; ⁴¹ merried 19 Jan. 1832, Tattnall Co., Ca., to Harriet Archer of Tattnall Co., ⁴² Identity of her parents has not been proven in spite of extensive research by a descendant, Mrs. May Walton of Augusta, Ga. The 1820 and 1830 censuses of Tattnall Co., Ca., show two Archer families living there at that time: James K. Archer and Thomas Archer. Descendants believe her mother was a Bryant but proof is lacking.

Josiah J. and Barriet Everitt lived in Tattnall Co. for seven years after their marriage. His name has been found in Tax Registers and other court house records.

On August 26, 1839, he bought Lot \$79, 400 acres in District 14 of Thomas Co., Ga., from William and John Dugger for \$1,645. On the same date he also bought Lot \$80, 450 acres in District 14 from Isaac Dugger for \$400.⁴³ Other property was bought and sold or transferred to sons of his children in the years which followed.

Just when the house which still stands was built is uncertain, but was probably between 1845 and 1850. Mrs. Walton has a picture of the house taken about 1880. On the front stoop are John Barber Everitt, son of Josish and Harriet Everitt, and his wife and two children, Lena and Walter. John B. Everitt inherited the house after his mother's death in 1878. He and his

family lived there and operated the plantation until he sold the property to his great nephew, Tom Mardre (grandson of John's sister Sarah Everett and her husband, Robert Burton Mardre). John B. Everitt and his wife Amelia Brown, moved to Boston, Ga., in Thomas Co. where they lived until they became too old to live alone. They them moved to Louisville, Ga., to live with their daughter, Lena Everitt Phillips. Lena's daughter, Mary Phillips Tinkler (Nts. Sam A. Tinkler of Greenwood, S.C.) has the original picture of the house Josiah J. Everitt built and she also has his family Bible with family records of the bitths, marriages, and deaths of the twelve children of Josiah J. and Harriet (Archer) Everitt.

Josiah J. Everitt died at home of pneumonia 26 Feb. 1873.44 His obituary from a Thomasville newspaper stated: "Maj. Josiah J. Everitt, a well-known, popular citizen of this county, died at his residence near the Florida line at 11 o'clock on Wednesday, the 26th ult. of pneumonia. Maj. Everitt was a successful farmer of indomitable energy and industry, and was noted for his honest simplicity of character, perseverance and good judgement. He has represented Thomas Co. in the Legislature, was a warm supporter of the County Agricultural Society and the South Georgia Agricultural if Mechanical Fair Assn., both of which he has represented with credit to their State Associations. He will be missed by these Associations, by his neighbors and by his fellow citizens throughout the county, who sincerely regret his death." Another clipping preserved by the family states that he was "a consistent, devoted and useful member of the Primitive Baptist Church. He loved the house of God and was never absent from his place unless providentially hindered."

Josiah J. Everitt was a Representative in the State Legislature in 1857-1858. He was a Justice of the Inferior Court from 1857-1861. How he got the title of Major is not known, but was probably from his Civil War activities. He was a member of the home guard, being too old to serve in the regular Confederate Army. However, his son, John B. Everitt, served during the entire war until he was wounded in Va. and was sent home on sick furlough shortly before the surrender in 1865.

Only one of Josiah J. Everitt's sons lived to adulthood, but five of his daughters grew up and married in Thomas Co. or Brooks Co., which was created from Thomas Co. and was near the plantation. One daughter, Mary, died about a year after her marriage and is buried in the family cemetery on the plantation, along with her parents, her paternal grandmother, Jane Carter Everitt, and several other relatives. Four of the children of Josiah and Harriet Everitt died within a few weeks of each other in the summer of 1856.

An inventory of the estate of Josiah J. Everitt⁴⁵ shows that he was quite well-to-do at the time of his death in 1873, even though it was relatively soon after the close of the Civil War. He owned 1677 acres of land in Lots 78, 79, 80, 105 and 106, in addition to stock in three railroads, 5760 in cash and much farm equipment and animals. The Tax Digest prior to 1865 has not been searched, but he undoubtedly had a large number of slaves. His son, John B. Everitt, was the administrator of his estate.
