## FOREWORD

It does not seem possible that it was in November of 1990 that I was putting together the foreword for "LAURENS COUNTY, GEORGIA LEGAL RECORDS 1807-1832". Two and one half years later, "LAURENS COUNTY, GEORGIA LEGAL RECORDS, SUPERIOR COURT, 1833-1857" is ready for the press. You may wonder why does the current book only contain the records of the Superior Court of Laurens County.

Most county records come from three main sources; Superior Court, Inferior or Probate Court, and Tax Commissioner. During the 1807-1832 period of Laurens County, no tax digest records are available. Because of the limited scope of the records for these first 25 years, I was able to put all the abstracts for the county into one publication, although it took 907 pages that weighed 5 pounds and 4 ounces.

During the 1833-1857 period of the county's history, considerable growth took place in the court records. This fact, coupled with the tax digests that are extant from the 1840's, made it physically impractical to put all of the county records for the 25 years into one publication. A second publication will be necessary to present the tax digests and the records from the Probate Court. I anticipate that it will be about two years before this work will be available.

Twenty-eight volumes, totaling over 6600 pages, were abstracted for this presentation and only about half of these volumes have been microfilmed. Current plans are for the unmicrofilmed volumes to be photo-copied and a copy to be presented to the Laurens County Public Library. This will allow the public the opportunity to secure a copy without damage to the fragile original documents.

Over 8400 computer entrys were generated from the 6600 pages and these entrys have been sorted and printed alphabetically by the principal in each document. Non-principal individuals are indexed in the master index. While the basic format of this publication is the same as the format of "Laurens County, Georgia Legal Records, 1807-1832", an attempt has been made to improve on that book by adding some new features.

First, I have made an effort to be more detailed in the document contents section of each abstract. This should further reduce your need to see or handle an original document. Secondly, I have added a section of maps of each Land District and Militia District. These maps were added at the suggestion of one of Georgia's premier genealogists and were replicated from an original 1903 map of Laurens County. Thirdly, I have indexed as principals both the grantor and grantee in deed records. This will make it easier for you to see if a person bought in and sold out during the 25 year time period.

With rare exceptions, the master index at the back of the book is a people-only index. My continued objective is to make it easy for the genealogist or historical researcher to quickly find every legal action in which an ancestor may have been involved.

I am not going to include a lengthy explanation of the founding and early years of Laurens County. For those of you who are interested in such an account, I refer you to my earlier publication. Only about 24 copies of this book are available and they may be ordered from me at Box 1719, Dublin, Georgia 31040.

I apologize for the numerous errors in this book. Some of the errors are errors of commission and some are errors of omission. Please know that all errors are of the head and hands and that none are of the heart. I have attempted to be exact as to the records as they were found by me. No effort has been made to clean up the clerk's spelling, so remember to think phonetics.

It is my most humble hope that this book will be of real benefit to you in your research. I obviously do not have the time to do your research and even find it difficult to answer your letters. Please know that these publications are designed to assist many researchers and not just a few. Happy research to each of you.

- KEY # 77. PETITIONS AND WRITS 1845-1849. This 322 page volume contains approximately 117 different petitions and writs recorded during the period indicated.
- KEY # 78. PETITIONS AND WRITS 1849-1852. This 529 page volume contains approximately 165 different petitions and writs recorded during the period indicated.
- $\underline{\text{KEY \# 79.}}$  PETITIONS AND WRITS 1852-1857. This 640 page volume contains approximately 347 different petitions and writs recorded during the period indicated.
- A Subpoena Docket is a volume that records the names of witnesses that have been summoned to give testimony in a case, either civil or criminal. These dockets are invaluable in that many of the names recorded in these volumes will not appear elsewhere.
- KEY # 50. SUBPOENA DOCKET 1828-1846. This docket is 75 pages in length and has the names of witnesses summoned in approximately 187 different cases.
- KEY # 66. SUBPOENA DOCKET 1848-1857. This 67 page volume contains the names of witnesses summoned in approximately 246 different cases.
- KEY # 67. SUBPOENA DOCKET 1857-1860. This docket book only contains the witnesses summoned in 8 different cases.
- KEY # 68. JUSTICE DOCKET 1855-1872. This volume is a docket of Charles L. Holmes, a Justice of Peace in the 52nd General Militia District in eastern Laurens County. While not technically a Superior Court record, the volume is of much historical value and worthy of inclusion in this publication. The volume is 300 pages in length and the first 68 pages are included here. Approximately 96 cases are covered in the 68 pages.
- KEY # 69. CERTIORARI DOCKET 1832-1856. This docket contains about 35 cases in 19 pages. Most of these cases had been tried at Justice of Peace courts and had been appealed to a higher court.

After a case has been tried and there has been a judgement awarded in the case, those judgements are recorded in Execution Dockets. The dockets provide notice that an award has been made to a party and the docket reflects whether that award is satisfied or is still owed. In addition, tax liens and other types of debts may be recorded in the Execution Docket.

KEY # 54. EXECUTION DOCKET 1832-1838. This docket is 145 pages in length and records the executions from approximately 212 separate actions. It may be that this docket is a docket from a Justice of Peace Court and that the Justice of Peace was Duncan D. Munroe.

- KEY # 80. EXECUTION DOCKET 1839-1856. This 164 page volume contains
  the monetary executions from approximately 556 cases.
- KEY # 81. EXECUTION DOCKET 1842-1846. This 56 page volume contains approximately 227 monetary executions recorded during the period indicated.
- KEY # 82. EXECUTION DOCKET 1856-1857. This volume contains an estimated 101 monetary executions in the first 86 pages.

The official court minutes are the recorded doings and actions of the court. These minutes contain court cases, court orders, jurys selected for future terms, grand jury presentments, and much more. All court records add completeness to the picture; but if you could only have one legal court record, the minute book is the one book you would want. It's kind of a summary of all of the court's actions.

- KEY # 40. MINUTE BOOK E. 1832-1840. This 225 volume contains an estimated 635 different actions of the court for the period indicated.
- KEY # 61. MINUTE BOOK F. 1841-1845. This excellent 184 page volume contains approximately 497 separate actions of the court for the period indicated.
- KEY # 62. MINUTE BOOK G. 1845-1853. This 322 page volume contains an estimated 664 separate actions of the court for the period indicated.
- KEY # 63. MINUTE BOOK H. 1853-1859. The first 322 pages of this 429 page volume were abstracted and contained therein were approximately 813 separate actions of the court for the period pre-1858.
