Rob. de S. to a deceased Jew, 26 June 1290 (C.R.). Protection, staying in Scotland for K with Henry, E. of Lincoln, 14 June 1291 (P.R.). He is bro. of Thos. de Marines, and has livery of Otterpool Manor as 1 Kt. Fee for maintenance of said Thos' w. and children, 10 Sep. 1298 (C.R.). Protection, going over seas for K. with E. of Lincoln, 2 Oct., and grant to him custody of lands val. \$16 14s. 111d., late of Thos. de Marines in minority of his s. h. Roger, and his marriage, with order to deliver the body of said heir to him to be married, 16 Nov. 1305 (P.R.). Certain men trespassed in his fishpond at Boghsted, Suss., t. Edw.
